#### What is the scholarship program?

The scholarship program is open to anyone looking for training and educational opportunities in the data privacy, ediscovery, legal technology, or cybersecurity industries. It takes place once a year and to date has brought more than \$300,000 in education to scholarship recipients. The TRU scholarship program is an annual program. The application process opens in the first quarter of each year, typically late January, and stays open for about a month. Scholarship winners are announced in early April, and scholarships are fulfilled from April through December.

#### What can I win?

You can get access to some of the best continuing education courses there are in the data privacy, ediscovery, and cybersecurity fields.



## What is the application process like?

The application will include questions about your background, your career experience, and your skill set. It will also ask for your resume, two professional references, and an answer to an essay question. We suggest subscribing to <u>TRU Insights</u> to be among the first to know when applications open.

## What do I need to have ready?

To make the application process go smoothly, ensure you have the following ready before you begin your application:

- A recent copy of your resume
- Two professional references



- The answer to one essay question: "How will receiving a scholarship help your career and/or your motivation for entering or delving deeper into the privacy, ediscovery, or cybersecurity industries?"
- A ranked list of which scholarships you'd prefer if you win.

# Can I apply again if I'm a past recipient?

Yes, all applications are judged anonymously so there is no issue with applying twice.

# How are the applications scored? Who evaluates these?

Applications are reviewed anonymously by a rotating board of industry leaders who then pair applicants with scholarships based on the best fit.

#### Is financial need considered?

We do not ask for financial information. The scholarships are assigned for best fit without any financial need considered.

#### When are the recipients chosen?

Typically, scholarship recipients are chosen, notified, and announced in early Q2 each year.

#### What's included?

Scholarships include the cost of the education or training. Scholarships do not include travel, lodging, or any other expenses.
